### **COSTS, FEES, DISCLAIMER:**

Recovery Point West Virginia provides training for Peer Recovery credential candidates that meets or exceeds the requirements of the West Virginia Certification Board for Addiction and Prevention Professionals (WVCBAPP). This training will require at least **46 hours** of time and commitment from each student.

**COST: \$500 per student** - covers instructor time and expenses, plus all course materials.
